



# Drug Take-Back Program

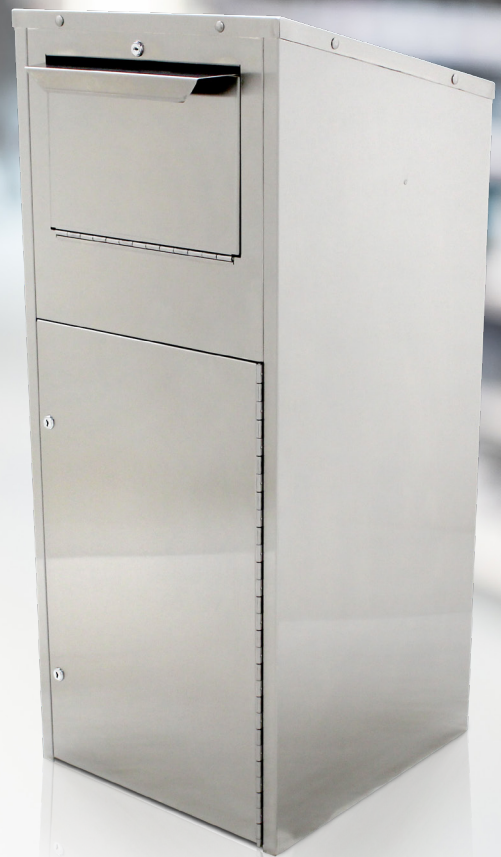
Help Keep Your Community Safe

The Pharma Logistics' Drug Take-Back Program is a simple and safe medication disposal program that helps keep your community safe and complies with the requirements of the DEA Secure and Responsible Drug Disposal Act. When prescription drugs are left unused in households it can impact a community's health and environment.



- ▶ 9.9 million Americans misused controlled prescription drugs in 2018 according to the DEA. Many times, access to those drugs comes from unused prescriptions stored in home medicine cabinets.
- ▶ Unused medications can lead to accidental poisoning. According to the CDC, over 300 children ages 0 to 19 are treated in an emergency department due to poisoning each day.
- ▶ When disposing of medicines, often times they are improperly discarded into toilets, introducing pharmaceuticals into water sources and potentially drinking water.

### Hopper Door

- Adjustable hopper door

### Access Door

- Anti-pry
- Two double-bitted registered keys – can't be copied

- Waterproof, tamper-evident and tear-resistant
- Removable and sealable without emptying or touching the contents
- Contents are not viewable from the outside when sealed

- A shipping container with a prepaid label
- DEA-approved disposal liner
- Serialized zip tag

- ✓ Over-the-counter medications
- ✓ Prescription drugs
- ✓ Controlled prescription drugs (Schedule II through Schedule V)

## Items we DON'T accept:

- ✗ Flammable liquids
- ✗ Illegal drugs (e.g., heroin, cocaine, ecstasy, marijuana)
- ✗ Medical waste
- ✗ Medical equipment
- ✗ Mercury thermometers
- ✗ Inhalers
- ✗ Sharps (e.g., needles, syringes, scalpels, lancets)
