
Guaranteed Payment Within 90 Days

Within 90 days of processing, your job will be fully reconciled and all payments will be received; eliminating the tedious process of closing jobs.



Simplify Funds Tracking

Once your job is processed in our fulfillment center, the inventory will be available on our customer portal and the corresponding funds issued will be reported.

The VA Drug Liquidation Program was developed over the course of two years, and we are confident our solution is easier to oversee, reduces risk, and takes the labor burden off your staff. Our goal in working with the VA is to help simplify the returns process and help better manage inventory while ensuring compliance.

VA Directive 1108.07 / PBM Guidance

> VHA Directive 1108.07. Page 16. "(a) Drugs designated as return for credit or destruction must be stored in a secure locked area with limited access and separated from normal inventory."

VA Drug Liquidation Compliance

- > We have partnered with a leading security kiosk manufacturer to create a secure locked kiosk for VA pharmacies to store their products designated for reverse distribution.
- ➤ Our kiosks are optional for those pharmacies already compliant with this requirement.

VA Directive 1108.07 / PBM Guidance

> VHA Directive 1108.07. Page 16. "(b) A current inventory must be maintained for non-controlled medications held for return for credit or destruction. At a minimum this list must contain drug name and quantity. Note: the contents of opened units or bottles may be estimated."

VA Drug Liquidation Compliance

➤ Pharma Logistics provides a web-based solution that allows VA pharmacies to inventory the products designated for reverse distribution. VA pharmacies will also be provided a scanner to simplify the pharmacy inventory requirement.

VA Directive 1108.07 / PBM Guidance

> VHA Directive 1108.07. Page 16. "(c) If using a reverse distribution vendor, vendor-provided reports must be analyzed to ensure appropriate credits."

VA Drug Liquidation Compliance

- ➤ Pharma Logistics ensures payment amounts will be available on our customer portal for analysis within 90 days
- > All data is fully exportable, allowing unlimited reporting capabilities.

VA Directive 1108.07 / PBM Guidance

➤ PBM Guidance "....services cannot be paid out of credits received. The payment mechanism must be set up separately, and you may want to consider a flat fee per pickup as an option."

VA Drug Liquidation Compliance

- > Pharma Logistics' will provide onsite services with a flat fee and the VA will be invoiced directly. Services will NOT be paid out of credits.
- > Invoices will be generated and submitted for payment according to contracted terms and following established payment processes.

With the VA Drug Liquidation Program, you will have an exact inventory before products leave your facility and you will receive funds within 90 days.

Service Explained

Pre-Onsite Service

- > VA pharmacy will request onsite service.
- ➤ The service event is scheduled, and the VA pharmacy will be contacted to confirm the date.
- ➤ In order to comply with VHA
 Directive 1108.07, VA pharmacy
 staff is required to keep an
 inventory of all products designated
 for return. To assist in this process,
 Pharma Logistics will provide
 access to our web-based inventory
 tool as well as a GS-1 scanner.

Day of Onsite Service Processing

- On the date of service, the Pharma Logistics field service representative will scan all indated, short dated, and expired medications designated for return. An initial determination of returnable or non-returnable will be made.
- ➤ Products that are deemed returnable are placed into a box to be returned to Pharma Logistics. All items that are determined to be waste will be separated. Segregated waste is eligible for our optional VA Drug Disposal Program or can be disposed of through your GEMS coordinator.
- Pharma Logistics field service representative will print an inventory which will contain the NDC, lot number, and expiration date of all products prior to shipment.

Shipping & Fulfillment Processing

- ➤ After the onsite process is completed, our field service representative arranges for shipment to our fulfillment center.
- All products received at our fulfillment center will receive priority processing.
- Pharma Logistics will submit its invoice to the VA pharmacy following established payment processes.
- Funds for your returnable products will be forwarded to McKesson for distribution to your account within 90 days.
- ➤ At the 90-day point, your pharmacy has received the following:
 - > A completed and closed job.
 - All funds distributed and reconciled.
 - Visibility into the entire process available on our customer portal.
